Dear Parents, Carers & Pupils

I recently wrote to you about a proposal to change the school day from September. I received feedback from over 300 pupils and nearly 150 parents and carers as well as from school staff and the Governing body. The vast majority of those who responded were in favour of the changes outlined in the proposal and I can therefore confirm that we will be switching to the new schedule for the school day from September:

The main benefits of this change are:

- 1. Improvement in the quality and consistency of fortnightly PSHE lessons during Monday form time.
- 2. The addition of a fortnightly, 40 minute guided reading session during Monday form time.
- 3. An earlier finish on a Friday afternoon.

Although the vast majority of parents were in favour of the changes, some concerns were raised and I'd like to address these concerns below.
